WHO CAN BENEFIT FROM WORKING WITH A COACH?

- Coaches may be assigned to a special education director, supervisor, coordinator, principal or assistant principal who is responsible for special education compliance and programming in their school.
- Administrators may be first time special education administrators, veteran administrators in a new district or they may be veterans in their role who would like to work on specific goals.
- Coaches are carefully matched with the administrator, taking into consideration the background of the coach and the identified needs of administrator.
